On February 1, 2023, the reporting person was granted performance share units ("PSUs"), with the number of PSUs earned to be determined based on the extent to which certain performance conditions were met for a performance period consisting of fiscal 2023. As determined on January 24, 2024, based on the Company's actual performance for 2023, the reporting person earned 5,065 PSUs, which are now the equivalent of RSUs with a service-based vesting condition and will vest as described in footnote 3.
- 3. The RSUs vest on February 1, 2026.
